- **LSFO** – is applied in addition to the current Bunker Adjustment Factor (BAF) and Emergency Bunker Adjustment Factor (EBR).
- **Foreign Exchange Rates (Forex)** – no change to the present practice, Forex will be applied per vessel basis and issued three working days prior to first sector port of call.
- **Monitoring Period** – will be held during 25TH Dec 2019 to 25th Feb 2020 with any changes to LSFO advised Mar 2020 for application April 2020.
