**Low Sulphur Fuel Surcharge Effective 21<sup>st</sup> of October**

Dear Valued Customers,

Pacific Forum Line wishes to advise that following monitoring of Low Sulphur Fuel (LSFO) price, for the last month, effective 21<sup>st</sup> of October an updated Low Sulphur Fuel Surcharge will be applicable on all shipments. LSFO price has increased by more than 10% during the monitoring period, triggering the new tier of the surcharge.

- Australia to / from South Pacific and Norfolk Island will be USD \$133 / TEU
- New Zealand to / from South Pacific Islands will be USD \$91 / TEU
- Inter-Island will be USD \$183 / TEU
