Dear Valued Customers,

Pacific Forum Line wishes to advise an updated Low Sulphur Fuel (LSF) Surcharge will be applicable on all shipment's effective 1st of April 2022. Because of rapidly increasing fuel costs LSF recovery calculation has been adjusted basis current costs.

Effective 1st of April 2022

- Australia to / from South Pacific and Norfolk Island will be USD \$342 / TEU
- New Zealand to / from South Pacific Islands will be USD \$234 / TEU
- Inter-Island will be USD \$471 / TEU
